## **TERMS & CONDITIONS OF THE AI IN HEALTH COALITION NEWSLETTER SERVICE**

### **§ 1. [GENERAL PROVISIONS]**

1. These Terms and Conditions of the Newsletter Service, hereinafter referred to as the "Terms and Conditions", set forth the rules for the provision of the service of providing content by electronic mail (hereinafter referred to as the "Newsletter service") by the Operator of the Service.
2. The Operator of the Service is wZdrowiu Limited Liability Company, with its registered office in Warsaw, at Żelazna Street, No. 59, apt. 1405, 00-848, post office Warsaw, having NIP 5272989565, REGON: 52126137800000, registered in the Register of Entrepreneurs, KRS 0000953569.
3. In order to use the Newsletter service, it is necessary to have access to the Internet and to have an electronic mail address (e-mail), while it is not necessary to meet any special technical requirements other than having a standard operating system and a standard web browser.

### **§ 2. [SERVICE SUBJECT MATTER]**

1. The Newsletter Service consists of sending by the Operator of the Service to the electronic mail address (e-mail) provided by the User, messages containing information on the overall activities of the AI in Health Coalition, available at [www.aiwzdrowiu.pl](http://www.aiwzdrowiu.pl), as well as the provision of information on events and projects on the subject of AI in the health sector and the provision of media and legal information, including the dispatch of conference materials on the conference indicated on the website <http://www.aiwzdrowiu.pl/> by the Administrator of personal data / service provider / conference organizer wZdrowiu Limited Liability Company (Żelazna 59/1405, 00-848, Warsaw).
2. The User, by concluding an agreement for the Newsletter service with the Operator of the Service, shall make available his/her name, e-mail address, represented entity and position, provided in the Newsletter form, for the purpose of receiving messages referred to in paragraph 1 above.
3. The Newsletter service shall commence upon the conclusion of the Newsletter service agreement.

### **§ 3. [TERMS AND CONDITIONS OF USE]**

1. The Newsletter service is free of charge.
2. The Newsletter service may be used by any person who provides his/her name, e-mail address, represented entity, position on the website in the domain [www.aiwzdrowiu.pl](http://www.aiwzdrowiu.pl) in the Newsletter form, and then clicks the "Register" button. Clicking the indicated button sends the provided personal data to the Service Operator and starts the Newsletter service provision.
3. When using the Newsletter service, the user is obliged to refrain from providing content of an unlawful nature, in particular in terms of providing someone else's data without the consent of authorized persons.
4. Individual messages, sent as part of the Newsletter service, constitute works within the meaning of copyright law and are subject to protection as defined by law. Any copying, modification and use in a manner inconsistent with its purpose or without the consent of the Operator of the Service may constitute a violation of the law.

### **§ 4. [DURATION OF SERVICE]**

1. The Newsletter service agreement is concluded for an indefinite period of time.
2. The user has the right to terminate the Newsletter service agreement. The termination shall have immediate effect.
3. The person using the Newsletter service shall terminate the agreement on the use of this service by sending a statement to this effect to the e-mail address: [biuro@aiwzdrowiu.pl](mailto:biuro@aiwzdrowiu.pl), by mail to the address of the Operator of the Service given in the provision of § 1 of the Regulations.
4. The Service Operator may suspend or terminate the Newsletter service after informing the User at the e-mail address provided by the User.
5. The Service Operator shall have the right to delete an invalid or non-existent e-mail address provided by the User.

### **§ 5. [PERSONAL DATA]**

1. In matters relating to the processing of personal data submitted in the course of providing the Newsletter service, the provisions of the Privacy Policy, the content of which is available at [www.aiwzdrowiu.pl](http://www.aiwzdrowiu.pl), shall apply.

### **§ 6. [VARANTY CLAIMS]**

1. Varanty claims regarding the Newsletter service should be submitted to the email address [biuro@aiwzdrowiu.pl](mailto:biuro@aiwzdrowiu.pl) or by regular mail directly to the Service Operator's address.

2. In the warranty claim there should be included the data of the person making the complaint, necessary to send information about the outcome of the complaint, as well as a description of what the irregularities in the Newsletter service consisted of and what are the expectations for the resolution of the complaint.
3. The Service Provider shall consider the complaint within 14 days from the date of its receipt.

#### **§ 7. [AMENDMENTS TO THE TERMS AND CONDITIONS]**

1. The Service Provider reserves the right to amend the Terms and Conditions. Amendments to the Terms of Service shall come into force on the date specified with the information about the amendment, but not earlier than after 7 (seven) calendar days from the moment of informing about the amendments to the Terms of Service, with the reservation that the amended Terms of Service shall be binding for the User, unless the User, within 7 (seven) days from the date of receiving the information about the amendment, declares resignation from the service in case of not accepting the new content of the Terms of Service. The User shall be notified each time the Terms and Conditions are changed to the electronic address provided by him/her in the Newsletter form.
2. Amendments to the Regulations of a technical or editorial nature shall not constitute an amendment to the Regulations.
